Tips for a smooth upgrade;

When you call to schedule your appointment, you will be asked for your address, account and PIN number. If you do not know your account or PIN number, you will need to provide at least two of the following pieces of information.

- Last four digits of the invoice number printed on your most recent statement
- Last four digits of your primary method of payment on file
- Account Number
- Email address on file
- Phone Number on file

If you are unable to provide these details you should visit the Summit Broadband office off Old 41 at 1443 Rail Head Blvd. Naples, 34110. Be sure to have ID with your Naples address.
